



Shepherd of the Hills Catholic School Tuition Assistance Guidelines

Families can apply for tuition assistance if they are unable to meet their financial obligation to Shepherd of the Hills Catholic School. Families who qualify for free or reduced-price meal benefits are encouraged to apply.

Tuition assistance is for tuition only. Participants who receive assistance are responsible for all other fees including but not limited to registration, child care, and lunch program.

- Tuition assistance may only be applied to tuition for 5-year-old kindergarten through eighth grade.
- Tuition assistance is not available for the 3 and 4-year-old kindergarten programs.

To be considered for tuition assistance please complete the following requirements:

- Complete registration and pay registration fee.
- Complete a Tuition Assistance Application and submit a copy of the most recent Federal Income Tax Return form 1040, 1040A, or the short form.
- Explain any special circumstances (i.e. change in income status, family status, health reasons, etc.)
- Be active participants in the Shepherd of the Hills Scrip program.
- Apply for Free & Reduced Hot Lunch benefits.

Because of the limited amount of money available, there is no guarantee that applicants will receive tuition assistance.

Please return this form and supporting income tax documentation to the school office by May 14, 2021.
